

**Brickman v. Fitbit, Inc.: Sleep Tracking Settlement Claim Form**

**1. Summary of Key Provisions**

The settlement will provide a \$12.50 cash payment (the “Settlement Benefit”) if you purchased, and registered online, a Fitbit Flex, Fitbit One, or Fitbit Ultra at any time: **in California or Florida from September 1, 2009 to October 27, 2014; in New York, Michigan, New Jersey, Pennsylvania or Ohio from March 26, 2012 to October 27, 2014; in Missouri or Illinois from March 26, 2013 to October 27, 2014; or in Texas, Georgia, North Carolina, or Washington state from March 26, 2014 to October 27, 2014.** Please refer to the full Notice for an explanation as to who is covered by the settlement.

To receive a Settlement Benefit, you must fill out and return the Claim Form found on this website (“Claim Form”), postmarked or electronically submitted on or before the dates explained in Part 5 below. If you fail to return a valid Claim Form by the deadline, your claim will be rejected and you will lose all rights to these benefits.

Unless you request exclusion from the class as explained in the full Notice, you will be bound by the Settlement Agreement and Release and the Final Judgment, even if you do not return a valid Claim Form.

**2. Who Is Eligible to Claim A Cash Refund Under the Settlement**

To qualify, you must have purchased, and registered online, a Fitbit Flex, Fitbit One, or Fitbit Ultra in the states and during the dates outlined above in Section 1.

**3. One Claim Form Per Subject Device**

If you purchased more than one of the subject devices (Fitbit Flex, Fitbit One, or Fitbit Ultra) during the relevant time periods and in the appropriate jurisdictions, and you wish to make claims for multiple devices, you must fill out a separate Claim Form for each device. You may print multiple copies of this Claim Form, or make photocopies, if necessary.

**4. How To Make A Claim for a Settlement Benefit**

To make a claim, complete and submit the Claim Form, in compliance with the instructions below. Send the original of the signed Claim Form to *Brickman v. Fitbit, Inc.* Settlement Administrator, P.O. Box 404104, Louisville, KY 40233-4104. Alternatively, you may submit the Claim Form online by clicking [HERE](#).

Please keep copies of your completed Claim Form(s) for your records.

**5. Claims Deadlines**

You must mail the Claim Form postmarked on or before May 30, 2019. **If you fail to return your Claim Form by the required date, your claim will be rejected, and you will be deemed to have waived all rights to receive a Settlement Benefit under this settlement.**

**Remember: To be valid, your Claim Form must be completely and accurately filled out, signed and dated, and must include all requested information. If your Claim Form is incomplete, untimely, illegible, or contains false information, it may be rejected by the Settlement Administrator.**
